

# CTSI Professional Competency Framework (CPCF) written examination

### **Guidance for this examination**

#### **Examination structure**

Section A Consists of six questions.

Candidates should attempt to answer four questions.

Section B Consists of four questions.

Candidates should attempt to answer two questions.

Total allocation of marks is 60 marks. Suggested time allocation is 60 minutes.

1. Briefly explain what the safety and marketing requirements for feed are in accordance with Retained Regulation EU 767/2009.

2. Annex II of Retained Regulation EC 183/2005 on feed hygiene makes it a requirement that Feed Business Operators must have written documented procedures for the identification of hazards in feed manufacture.

Explain the principles on which these written documented procedures must be based.

(10 marks)

3. Retained Regulation EC 852/2004 on the hygiene of foodstuffs places requirements on food business operators to put in place hygiene provisions to ensure that primary products are protected against contamination.

Explain what these hygiene provisions include.

(10 marks)

4. For the levels of primary production and associated operations, a Feed Business Operator needs to comply with the provisions of Annex I of Retained Regulation EC 183/2005.

Explain what primary production for feed is and what is included in the associated operations.

(10 marks)

- 5. The safety requirements for placing feed on the market are detailed in Retained Regulation EC 178/2002. Explain the safety requirements for feed as per Article 15 of these regulations. (10 marks)
- 6. The relevant Feed Law codes of practice for England, Scotland and Wales make it a requirement that competent authorities must have "appropriate equipment to undertake the full range of feed controls in their area, including sampling".

With examples on use, detail the sampling equipment that a local authority should consider holding in order to comply with this requirement.

10. As part of your local authority performance plans, you have been tasked with drafting the service delivery plan for feed. Explain, in full, what must be included as part of this plan to ensure compliance with the relevant Feed Law Codes of Practice.
