Have you contacted your verifier?

Have you contacted your regional verifier? This will be the person responsible for signing off your portfolios. There is a regional verifier for each region across the United Kingdom. This information can be found in the Stage 2 info tab:

• Who is the verifier for my Local Authority?

Do you have an assessor for each of your portfolio's?

For each of your portfolios you will need an internal assessor. This will be the person responsible for assessing each element of your portfolio. This person will need to be somebody internal within your Local Authority. Each assessor will need to be competent in the Unit subject that they will be assessing, as well as completing a yearly CPPD course to confirm their competency with assessing portfolios. We offer both a yearly online course for experienced assessors as well as a New & Upskilling assessors' course, for new assessors or those who haven't assessed a portfolio in some years.
