

## **Transition into the Qualification Framework**

## **Fees**

These transition fees are for candidates with an existing qualification, such as CSCATS, DCATS or equivalent, that wish to transition into the Qualification Framework using exemptions from a unit or individual element within a Stage.

**Registration Fees** – Each candidate must pay a registration fee. This fee will differ dependant on whether a candidate wishes to complete a single unit, or a whole stage to gain certification.
