# **Intelligence and Investigative Principles**

### 8. Answer **all** parts

You are Jane Brown, a trading standards officer with Blankshire Council. You have received a high volume of complaints from consumers about unsafe cars purchased from Rubbish Vehicles who are based in your area.

(a) Explain what initial steps you will take to understand the scale of the problem.

(8 marks)

You now have a better understanding of the problem and, as your investigation progresses, you decide to conduct an interview under the Police and Criminal Evidence Act 1984 (PACE) [in Scotland, the Criminal Procedure (Scotland) Act 1995] with Mr Rubbish, the owner of Rubbish Vehicles, whose first language is not English.

(b) Discuss how you will comply with PACE Code C to ensure that Mr Rubbish is treated fairly and appropriately both before, during and after the interview.

(6 marks)

Following the interview, you have sufficient information to submit a report to your senior officers recommending a prosecution.

(c) Explain the importance of your authority's enforcement policy and how you will have adhered to this throughout your investigation.

You are Bob Blank working with Blankshire Council. You are leading a complex investigation which has uncovered a number of vulnerable people who have been affected by the criminality.

(a) Discuss how you will ensure that you achieve best evidence from the vulnerable people who have been targeted.

Best evidence has been achieved and you have obtained a high volume of evidence relevant to your investigation.

(b) Explain how you will ensure compliance with all record keeping requirements.

(6 marks)

Your investigation progresses and you prepare a Prosecution Report, including a schedule of evidence, to submit to your senior officers.

(c) Discuss the importance of a schedule of evidence and, using examples, explain what it should contain and what hearings may be applicable.

This business has generated a high volume of complaints from consumers in both your area and in the neighbouring authority, Blink Council. You decide to conduct a raid at the registered address for 'wegotyou.com', which is on an industrial site spanning the borders of your authority and Blink Council.

(a) Discuss your powers of entry and what processes you would need to undertake to enable the raid to occur.

During the raid, you mainly seize digital evidence, including computers, smart phones and other technical equipment.

(b) Explain how you will comply with the legislation that governs the gathering of digital evidence and the appropriate steps you should take.
